**NOTICE TO RESIDENTS FILING A SWORN AFFIDAVIT
PERTAINING TO FREE SCHOOL PRIVILEGES FOR A
NON-RESIDENT CHILD**

Under the terms of section 24 P.S. §13-1302 of the Pennsylvania School Code of 1949, **as amended**. IF IT IS FOUND THAT INFORMATION CONTAINED IN THE SWORN STATEMENT IS FALSE, THE CHILD MUST BE REMOVED FROM THE SCHOOL AFTER NOTICE OF AN OPPORTUNITY TO APPEAL THE REMOVAL PURSUANT TO THE APPROPRIATE GRIEVANCE POLICY OF THE SCHOOL DISTRICT.

NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, A PERSON WHO KNOWINGLY PROVIDES FALSE INFORMATION IN THE SWORN STATEMENT FOR THE PURPOSE OF ENROLLING A CHILD IN A SCHOOL DISTRICT FOR WHICH THE CHILD IS NOT ELIGIBLE COMMITS A SUMMARY OFFENSE AND SHALL, UPON CONVICTION OF SUCH VIOLATION, BE SENTENCED TO PAY A FINE OF NO MORE THAN \$300.00 FOR THE BENEFIT OF THE SCHOOL DISTRICT IN WHICH THE PERSON RESIDES, OR TO PERFORM UP TO 240 HOURS OF COMMUNITY SERVICE, OR BOTH. IN ADDITION, THE PERSON SHALL PAY ALL COURT COSTS AND SHALL BE LIABLE TO THE SCHOOL DISTRICT FOR THE COST OF TUITION AS ESTABLISHED BY LAW DURING THE PERIOD OF ENROLLMENT.
