- April 3rd we were at 2.74% increase, 1.4% delta
- Since then there have been positive changes that change the Budget
- Title I \$50,000. Increase
- Medical Access added as well
- Changes in benefits
- Savings on Retirements
- Additional Staff, ½ Math Teacher at the High School, .5 Secretary in Pupil Services, Wilson Reading Specialist
- New Text Book adoption
- New technology at the High School
- Update on the Wireless access
- .88% tax increase
- Revenues are up
- Increase in assessments
- Transfer tax has increase over the years
- State pays 50% of pension and social security

• There will be a positive variance again this year
