- **4.08** Transportation Discussion Item(s)
  - 1) As of September 6, 2022, we are providing bussing to 120 schools on a daily basis, which totals 375 daily bus routes. The MNSD Transportation employees are transporting nearly 4,583 students per day.
  - 2) 2022-2023 bus route notifications were available to parents on Monday, August 22.
  - 3) "Here Comes the Bus" module is in the process of being integrated with Transfinder Plus Bus Routing system with the hope that the application be rolled out to all MNSD parents no later than Friday, September 23, 2022. Information regarding the "Here Comes the Bus" application, general information and enrollment instructions will be placed on the district web page.
  - 3) To date, 56 "hazardous routes," as deemed by PennDot, have been identified within our school district boundaries and have been "geo-coded" into the Transfinder bus routing program. The identification of these areas results in providing additional bus routes in order to have our children arrive safely to school.
  - 5) Mandatory Bus Evacuation Drills will take place during the month of September.
