A. Discussion: Field options for the High School Fields Renovation Project

Mr. Bonett gave the following update on the fields:

- B. Update on LED Lighting
 - Mr. Dumin explained wording in Act 129 would not be an advantage to us unless bigger project. PECO would be a higher rate, but usage would be down, then the cost would be less. Looking into a larger scale project, will get more information
- C. Discussion: Variance Application fee and recommended attorney needed for Petition for Zoning Hearing Board for the new sign at the High School
