- Age and gender ~ numbers as of the 2010 census
- Both Townships ~ middle age or seniors staying in townships
- Combined births ~ 290 average per year ~ trend 6 more per year
- Residential sales ~ maybe around 300
- Residential permitting ~ new development
- Information does not include Cardinal Crossing
- 260 new students from new housing
- 68 students from other housing
- · Different multipliers depends on what type of housing
- Divide number of students by 13
- No impact for private/charter schools
- Population is stable in both townships
- Worked with 6 years of data ~ births 5 years prior
- Take enrollment x 1.237 adjust to actual enrollment
- Enrollment higher in elementary and middle, decrease in high school
- Culbertson would have a large increase
- Loomis also increase at capacity in 4 years
