### 4. Informational/Discussion Items ~ Facilities

A. Presentation: Pete Medica from Bonnett Associates on the High School Field Renovations Project and discussion on the type of synthetic turf for the project.

The following presentation was given:

- Met with representatives from Newtown Township
- Explained the scope of the project and it was very well received
- Stadium ~ replacing the turf, track and lambs
- Turf on the baseball and softball fields
- Natural turf on JV fields
- Varsity and Softball dugouts, batting cages, bull pens
- Field House, team rooms, training rooms, bathrooms and public bathrooms
- Concession stand
- Soil testing done for storm water management
- Numbers less than favorable, waivers would be required
- Showed the existing fields, overview of what the fields will look like
- Work on the stadium this summer.
- Explained the retainer walls would end at the JV baseball field
- Talked about the scoreboards
- Access walk would be wider
- Again explained that waivers would be needed for storm management
- Possible better soil at the Gauntlett Center, site would have to be looked at to see if it would work
- Could take up to 120 days for testing, only cost would be fees
- Will continue with variances and also will check out the Gauntlett Center
- B. Request from the Marple Newtown Youth Lacrosse for the use of the Stadium:
  - Monday Friday from March 6<sup>th</sup> to June 9<sup>th</sup>, 6PM to 8PM
  - All Saturdays from March 12<sup>th</sup> to June 4<sup>th</sup>, 2PM to 6PM
  - All Sundays from February 19<sup>th</sup> to March 12<sup>th</sup>, 12:30PM to 4PM
  - All Sundays from March 19<sup>th</sup> to June 11<sup>th</sup>, 12:30PM to 6PM

Marple Newtown Youth Lacrosse is also request that all fees be waived.

C. Recommendation for a motion to approve the disposal of a Genie Lift. This lift was declared unsafe at the last inspection and has been replaced.
