I. Call to Order

Ms. Chandless is leading the meeting on behalf of Mr. Altieri this evening and called the meeting to order at 7:37 p.m.

II. Pledge of Allegiance

Ms. Chandless led the audience in the Pledge of Allegiance.

III. Approval of Minutes

The November, 2018 minutes were approved by the committee.

IV. Approval of Agenda

The Agenda was approved with the following addition:

Donation:

L. Motion to approve the Paxon Hollow Middle School PTO donation to purchase 2 Art displays for the Art Show in the amount of \$1,269.98 and ten monitors, mounts, and computers for the hallways in the amount of \$10,537.60.

V. Discussion/Informational Items

A. College and Career Transition (CCT) Course – Mrs. Christa Palladino

Mrs. Palladino reported on the new proposed course entitled "Career Pathways" which the high school would like to propose and introduce to 10th grade students. She reported that 90% of STEM jobs will require post-secondary training, and there is currently a 45% skills gap in this market. In 1989, under Chapter 339 school code, federal funds were allocated to career and technical programs. Pennsylvania already has a K-12 plan in

place and this course would bring together things we are currently doing with direct instruction and the opportunity to store artifacts. It would focus on college recruitment, SATs, career opportunities, financial information and trade schools. The course would run 3 of a 4 day cycle for a semester and staff is already available by reallocating resources in the building. Curriculum was purchased through Naviance and other schools in the area are willing to share materials. Any additional costs would be for three days of professional development for four staff members at \$3,432.00.

B. Proposing an amendment to include the elementary honors choir (30 students) to travel to the Dorney Park Music Festival to be adjudicated on the same day as the Middle School Band and Chorus trip that was board approved in November, 2018. The elementary staff and students would leave on Friday, May 31st with Paxon Hollow and perform at a local high school for an adjudication followed by time at the park and the awards ceremony – Mrs. Mary Anne Hrin and Mr. Dan Peters. Mrs. Hrin and Mr. Peters proposed to include 30 elementary honors choir students to join the Middle School trip to Dorney Park. It will provide the opportunity for students to perform and receive immediate feedback and comments. The Committee agreed this would be a productive opportunity for these students.

VI. Motions:

There was a motion to approve the addition of the course "Career Pathways". There were no further comments on agenda motions or addendum donation, and all motions have been moved along to the full Board.
