We have accomplished much. We added four new STEM focused courses to our high school offerings, all of which have high student subscription.

We implemented new college access/admission software that is student-driven (SCOIR),

We changed the ranking and GPA structures at the high school in order to provide a more personalized experience for our students and to truly be able to show colleges our students in light of who they are rather than merely where they rank.

We enjoyed the benefit of a half-time instructional technology coach to help teachers use technology in new ways for teaching and learning processes.

We enjoyed the third straight year as Cavalcade of Band Champions in the Yankee Division. We enjoyed a winning high school football team and a winning baseball team. Our middle school basketball team earned the championship and even our youngest hockey players in the community made us very proud!

We graduated 285 students, with 93% of them going on to post-secondary education, and being awarded 14 million, 380 thousand dollars in scholarships and awards.
