She also explained that the cost drivers are salaries, benefits and pension. Also, Federal and State regulations are that we cannot raise cost of lunches more than \$.10, our lunches are subsidized. We could take the High School off the program, but we do not know what negative impact that would have. The subsidized lunch program is tied into the Title I program as well as the E-rate.

10. 2016-2017 Proposed Final Budget

Mr. Driscoll gave the following presentation:

- Proposed Final Budget vote this month
- June 28th would be the final vote
- State Budget passed without the Governor's signature
- Did receive some funds for Block Grant \$109,000.00
- Explained the Basic Ed Funding
- Plan-Con dollars has not be distributed, about \$300,000.00
- 2016-2017 State Budget not fast moving
- Our Budget would be status quo
- Index is 2.4%

- Exceptions do not apply
- Local sources are higher at this time
- Assessment growth \$118,332,317. Marple \$15,337,268, Newtown \$102,994,949.
- Collection rate 96.5%
- Interim and transfer taxes have increased
- Explained the State share of PSERS
- Explained expenditures, Salaries, Benefits, Medical, and Pension which should plateau in a few years. Medical there is a 6% increase RX 10% increase.
- The Budget also includes Textbook and Software adoptions which Dr. Bompadre explained. Dr. Bompadre also explained the assignment of a .05 FTE Technology Teacher and .05 FTE Instructional Tech Coach K-12, Mr. Dumin explained the request for additional personnel for Operations, 3 full time for grounds and 1 custodian at the High School and vehicle replacement.
- Mr. Driscoll also explained the addition to the Autistic Support Program, 1 full time teacher at the High School as well as a full time Special Ed Assistant
