Mr. Driscoll explained that the large bill is the debt service payment. Other than that it has been a normal month.

5. Taxpayer Request for Abatement of Penalty

7. 2015-2016 Budget Update

Mr. Driscoll gave the following report:

- The exceptions that were applied for have been approved.
- We show no short fall.
- Three major sources State, Local, and Federal this district gets most of the funds from Local resources, 84% is Local, and 15% is State.
- The department budgets are coming in.
- Salaries and benefits are the largest part of the Budget.
- He explained the different budget codes. There are 3,000 different budget codes, if any Board member would like to look deeper into the codes, just let him know.
- Reduction in Medical premiums.
- Vision and Dental are not increasing.
- Prescription Plan is now at 21%. The cost is due to specialty drugs.
- Some increases in the Technical School tuition.
- In Transportation, the radio system will have to be replaced, also catching up on the gas pricing.
- DCIU fair share up a small amount.
- Increase in revenue, assessment growth, and delinquent tax projection up, transfer tax a little higher and interim taxes.
- Not sure what will happen with funding from the State
- Estimate at 3.05% tax increase
- Vote on proposed Budget at end of month.
- Will have a presentation for staffing in May.
- Final vote in June.
- He can always e-mail more information to the Board if needed.
